The Trustees present their annual report and financial statements of the charity for the year ended 31st December 2019. The financial statements have been prepared in accordance with the accounting policies set out in note 1 to the accounts and comply with the General Assembly Regulations for Congregational Finance, the Charities and Trustee Investment (Scotland) Act 2005, the Charities Accounts (Scotland) Regulations 2006 (as amended) and Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland published on 16th July 2014.

Objectives and Activities

The Church of Scotland is Trinitarian in doctrine, Reformed in tradition and Presbyterian in polity. It exists to glorify God and to work for the advancement of Christ's Kingdom throughout the world. As a national Church, it acknowledges a distinctive call and duty to bring the ordinance of religion to the people in every parish of Scotland through a territorial ministry. It co-operates with other Churches in various ecumenical bodies in Scotland and beyond.

Drumoak-Durris Church is part of the Presbytery of Kincardine and Deeside. In the parish of Drumoak-Durris, regular Sunday morning worship takes place on alternate weeks in the two churches. Additional services are conducted in accordance with the Christian calendar. The educational, spiritual and fellowship development of the congregation continues to be advanced within various group activities, which comprise of Home Groups, Messy Church, Friendship Club, Drumoak-Durris Singers and Coffee, Craft and Chat mornings.

Outreach is undertaken through nursing home, hospital and personal home visiting. The Pastoral & Worship Group has undertaken a programme of informal afternoon meetings for worship and refreshments for the senior members of the congregation and wider community, and these are growing in popularity. This group has also introduced a voluntary transport facility for those who have difficulty in reaching hospital and other such appointments. SPLAT continues to offer a lively music group which welcomes babies, pre-school children and their parents or carers. Throughout the year, the Friendship Club for the more senior members of the parish meets in the Church Hall, and contact with the local primary schools continues to be strengthened. In addition, the Minister has also become a member of the team, which visits Banchory Academy, and regularly leads the year group assemblies. Baptism, Marriage and Funeral services are available to all members of the parish.

Drumoak-Durris Church continues to produce a 'Church News', which is included in the quarterly Community Newsletter. This publication now has an editorial team, which is supported by the local Drumoak & Durris Community Group. Members of

the congregation still have an active role within the team responsible for the distribution of the Newsletter, and this work is co-ordinated by a member of the congregation.

The Church's website continues to be reviewed and updated, and audio recordings of the regular Sunday Services are available for downloading. The website continues to be a valuable source of information about the Church's activities and its involvement within the wider community. Following its introduction in 2016, the Church's Facebook page has been successful in its communication with the congregation and wider community. The Parish Profile is available for consultation on the website, and has been identified as in need of review and refreshment during this coming year.

The Church continues to support community activities in the Church Hall at Drumoak. There is the ongoing use of the facilities at Drumoak Church Hall by the local Cubs and Beavers groups. SPLAT continues to attract a number of local families, and Jolly Tots has been adopted as a Church group. Each of these groups has seen a continuing increase in attendance from the growing number of young families within the area. The local informal music group, which meets on a regular monthly basis in the Church Hall, continues to grow in popularity. Following on from the increased attendance at these musical evenings, this small group of musicians are now becoming a regular attraction at various other community events. The Church Hall continues to provide a venue for community meetings, a polling station, private functions such as birthday parties and various other family and community events and celebrations.

Achievements and Performance

Unfortunately in early 2018, all work stopped on the refurbishment of Drumoak Church. This decision was not reached easily, but the events of 2017 had presented the team with no other option. As previously reported, the scope of work had grown following the discovery of additional work required to address the structural problems within the building. Many of these structural defects have been remedied, but some of the other work needed – for example to the windows – will require specialist renovation and refurbishment. As Drumoak Church is a listed building, not only will planning permission be required, but additional consents will also be needed.

Meantime, options for the completion of the work had to be considered, and costings for the revised programme had to be estimated. This had turned out to be a much longer process than ever imagined and crucial decisions needed to be made by the Trustees. Estimated costs have been allocated to each of the possible scopes of work and these have been presented to the Trustees for review. Following extensive research carried out by those involved with the project, the Trustees met in August 2019 to review and discuss the various options identified for the completion of the project. At this meeting, it was agreed the Property and Finance Group should progress the project in a staged programme. Initially the work required within the present building has been assessed, agreed and initiated at an estimated cost of

£1.5 million. Thereafter, work would begin on the planned extensions to the front and rear of the present building. An estimated cost for this work being in the region of a further £1.5 million. Work is unlikely to begin in the foreseeable future as planning permission and consents need to be applied for and negotiated. Drumoak Church is a Grade B listed building, which poses certain restrictions as to what work can be carried out.

However since the work has stopped, a great deal of 'behind the scenes' progress has been made. There has been an ongoing succession of meetings, discussions, seminars and research happening. Consideration has been given to the assets of Drumoak-Durriss Church, and to how these can be best used to help finance any future work. In addition, there has been a continuing fund-raising programme, which has resulted in a substantial amount of money being raised. In comparison to the estimated costs of the work, it may seem to be a 'drop in the ocean', but in reality it is a demonstration of the drive to take forward this ambitious plan for the Drumoak Church building.

Home groups continued to meet regularly during the early months of 2019 for a varied programme of study and fellowship. Among the topics on offer have been A Lent Study, which was well attended. The Minister led a very popular Alpha Course during the second half of 2019. Attendance had been especially pleasing with a group of up to 18 individuals regularly attending. In response to a request to continue meeting, many of those who attended the Alpha Course have been meeting together for an Alpha follow-up Bible Study, and concentrating on the Ten Commandments.

As the year progressed, the Minister continued to offer a varied programme of worship. Members of the congregation regularly led the prayers of intercession, and read the lesson. A 'Back to Church' service was conducted on Sunday, 12th January in Drumoak Church Hall. In March, a Pulpit Exchange saw the Minister preaching at Peterculter Church, and Rev John Ferguson led the worship at Drumoak-Durriss Church. The Annual Stated Meeting was held during the service at Durriss Church on Sunday, 24th March, 2019.

The Easter worship programme for 2019 opened with a Maundy Thursday Evening Communion Service in Drumoak Church Hall, followed on Good Friday with an evening candle lit vigil in Durriss Church. On Easter Sunday, the early morning open air service at Durriss Church was followed by a Messy Church Breakfast in Drumoak Church Hall, where craft activities were offered for the young people who attended, and an All Age Family Service followed.

The regular annual Communion Services were held in May at Drumoak and in October 2019 at Durriss Church. The Communion Service on 12th May 2019 Drumoak Church Hall was served during the Christian Aid Breakfast offered that morning. This service was conducted not only with a feeling of informality, but also a sense of intimacy for the members of the congregation, as they shared worship and Holy Communion around small tables.

On 29th September the Church celebrated Harvest Thanksgiving and, as on previous occasions, the gifts were delivered to the local foodbank for distribution.

The Remembrance Day Service was held in Drumoak Church Hall on 10th November 2019. The Act of Remembrance at the war memorial was well attended and wreathes were laid by both the Church and the Scouts groups. Afterwards an informal wreath laying also took place at the Durriss war memorial. On 17th November 2019, a special service commemorated the 150th Anniversary of CrossReach, and a presentation concentrating the present day work of this organisation was enjoyed by the congregation.

The Christmas Worship Programme for 2019 began with the services marking the first, second, third and fourth weeks of Advent, and the distribution of a number of 'take-away' hand crafted angels; each with a short Bible verse attached. These angels were strategically placed around the parish for residents to collect and take home. This simple offering of a small gift to local residents received an overwhelming response. The annual Family Nativity Service was held in Drumoak Church Hall in the early evening of Tuesday, 24th December, with refreshments served afterwards. This all age interactive Family Service was well attended and enjoyed by children and adults alike. Later on Christmas Eve, a traditional Candle-Lit Watchnight Service was held in Durriss Church. This year, the Christmas Day Service in Drumoak Church Hall was exceptionally well attended as families from far afield gathered together. The final service of Lessons and Carols was held on 29th December in Drumoak Church Hall, and was led by the members of the Pastoral & Worship Group. Donations from the Christmas services was shared between the Aberdeen Samaritans and Aberdeen Street Pastors.

During 2019, Drumoak-Durriss Church participated in the Local Church Review organised by the Presbytery of Kincardine and Deeside. This exercise began with the preparation of documents which recorded the facts and figures of the parish, a report which depicted 'Your Church Today', an analysis of the 'Roots & Fruits' of the church and its congregation and a breakdown of the congregational statistics. Once these had been forwarded to Presbytery, a team of nominated representatives from Presbytery met with the Elders and, after joining the congregation for one of the Sunday Services, met and mingled with the congregation before meeting privately with the Minister and her husband. A short time later, the representatives from Presbytery prepared and forwarded a report, which has subsequently been presented to Presbytery for review.

Financial Review

During the year a surplus of £9,164 was recorded. This compared well with a deficit in 2018 of £87,522.

In 2019, Net Income (income less expenditure) of £4,690 was incurred in connection with the Development Project at Drumoak Church. The corresponding Net Costs in 2018 were £82,494.

In terms of other income sources, there were favourable variances when compared to 2018, relating principally to an increase in Legacies (£1,663), in Offerings (£2,012), in Tax Recovered on Gift Aid (£2,133).

In terms of non-Development Project expenditures, there were unfavourable variances when compared to 2018, primarily coming from an increase in Fabric Repairs and Maintenance (£3,560)

While it is positive to see a slight increase in congregational income compared to 2018, it is likely that we will encounter recurring deficits for the foreseeable future unless ways can be found of maintaining a year-on-year increase in congregational income, ideally through increases in membership, and importantly sustainable increases in individual levels of giving.

Investment Policy and Performance

At 31st December 2019, we had available funds of £196,178, including investments of £49,717. Over 90% of available funds are held in short term assets to meet the possible needs of the Development Project.

Risk Management

The principal risks facing Drumoak-Durris Church are thought to be:

- Declining membership,
- Younger age groups not currently well represented within the membership,
- Recurring financial deficits,
- Major unplanned property repairs,

The above can be mitigated by the following:

- Ongoing focus upon Stewardship,
- Greater level of community involvement,
- Responsible spending controls,
- Adequate levels of financial reserves.

Reserves Policy

The Kirk Session has considered the level of reserves required, and has taken into account current and future liabilities. Our policy is to hold a minimum working reserves of approximately six months' expenditure, and that was the position at year end.

Structure, Governance and Management

The congregation is a registered charity, number SCO33779, administered in accordance with the terms of the Deed of Constitution (Unitary Form) and is subject to the Acts and Regulations of the General Assembly of the Church of Scotland.

Members of the Kirk Session are the charity trustees. The Kirk Session members are the Elders of the Church and are chosen from those members of the Church, who are considered to have the appropriate gifts and skills. The Minister, who is a member of the Kirk Session, is elected by the congregation and inducted by Presbytery. The Kirk Session, which meets at least four times a year, is responsible for the spiritual affairs within the Church. Certain responsibilities are delegated by the Kirk Session to sub-committees.

Statement of Trustees' Responsibilities

Independent Examiner’s Report to the Trustees of Drumoak-Durris Church of Scotland

I report on the accounts of the charity for the year ended 31st December 2019 which are set out on the following pages.

Respective responsibilities of trustees and examiner

The charity’s trustees are responsible for the preparation of the accounts in accordance with the terms of the Charities and Trustee Investment (Scotland) Act 2005 and the Charities Accounts (Scotland) Regulations 2006.

The charity trustees consider that the audit requirement of Regulation 10(1) (a) to (c) of the Accounts Regulations does not apply. It is my responsibility to examine the accounts as required under section 44(1) (c) of the Act and to state whether particular matters have come to my attention.

Basis of independent examiner’s statement

My examination is carried out in accordance with Regulation 11 of the Charities Accounts (Scotland) Regulations 2006. An examination includes a review of the accounting records kept by the charity and a comparison of the accounts presented with those records. Drumoak-Durriss Church of Scotland Accounting Policies

The principal accounting policies, which have been applied consistently in the current and preceding year in dealing with items which are considered material to the accounts, are set out below.

Basis of preparation

The financial statements have been prepared in accordance with Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standards applicable in the UK and Republic of Ireland (FRS102) issued on 16 July 2014 and the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS102), the Charities and Trustee Investment (Scotland) Act 2005 and the Charities accounts (Scotland) Regulations 2006 (as amended)

Funds

Funds are classified as either restricted funds or unrestricted funds, defined as follows.

Restricted funds are funds subject to specific requirements as to their use which may be declared by the donor or with their authority or created through legal processes, but still within the wider objects of the charity.

Unrestricted funds are expendable at the discretion of the trustees in furtherance of the objects of the charity. If parts of the unrestricted funds are earmarked at the discretion of the trustees for a particular purpose, they are designated as a separate fund. This designation has an administrative purpose only and does not legally restrict the trustees' discretion to apply the fund.

Incoming resources

Income is recognised when the charity has entitlement to the funds, any performance conditions attached to the item(s) of income have been met, it is probable that the income will be received and the amount can be measured reliably.

Donated services and facilities

Donated professional services and donated facilities are recognised as income when the charity has control over the item, any conditions associated with the donated item have been met, the receipt of economic benefit from the use by the charity of the item is probable and that economic benefit can be measured reliably. In accordance with the Charities SORP (FRS102) the general volunteer time of congregation members is not recognised.

On receipt, donated professional services and donated facilities are recognised on the basis of the value of the gift to the charity which is the amount the charity would have been willing to pay to obtain services or facilities of equivalent economic benefit on the open market; a corresponding amount is then recognised as expenditure in the period of receipt.

Interest receivable

Interest on funds held on deposit is included when receivable and the amount can be measured reliably by the charity; this is normally upon notification of the interest paid or payable by the Bank.

Fixed Assets

The charity has the right to occupy and use for its charitable objects certain tangible fixed assets, including the Church, halls and manse, vested in the Church of Scotland General Trustees. No consideration is payable for the use of these assets. Expenditure incurred on the repair and maintenance of these assets is charged as resources expended in the statement of financial activities in the period in which the liability arises.

All tangible fixed assets costing in excess of £10,000 having a value to the charity greater than one year, other than those acquired for specific purposes, are capitalised. Depreciation is provided on a straight-line basis to write off the cost or initial value, less residual value, of tangible fixed assets over their estimated useful lives.

Investments

Fixed asset investments are stated at market value at the balance sheet date. Unrealised gains and losses represent the difference between the market value at the beginning and end of the financial year or, if purchased in the year, the difference between cost and market value at the end of the year. Realised gains and losses represent the difference between the proceeds on disposal and the market value at the start of the year or cost if purchased in the year.

Taxation

Drumoak-Durriss Church of Scotland is recognised as a charity for the purposes of applicable taxation legislation and is therefore not subject to taxation on its charitable activities. The charity is not registered for VAT and resources expended therefore include irrecoverable input VAT.

All Church of Scotland congregations contribute to the National Stipend Fund which bears the costs of all ministers' stipends and employer's contributions for national insurance, pension and housing and loan fund. Ministers' stipends are paid in accordance with the national stipend scale, which is related to years of service. For the year under review the minimum stipend was £ 27,585 and the maximum stipend (in the fifth and subsequent years) £ 33,899.
